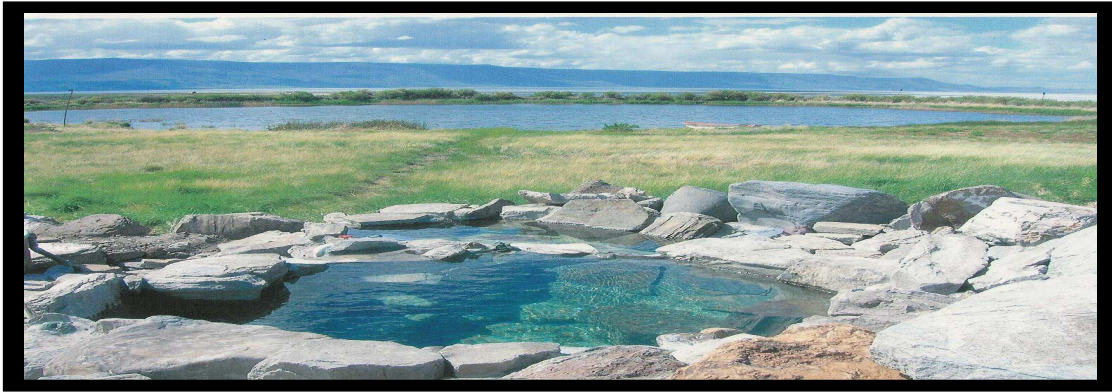

CONTRACT GUIDELINES

A copy of this signed contract is a confirmation of the agreement between the Vendor and Summer Lake Hot Springs Coyote Music Festival.

Vendor Agrees to:

Set Up Options:

1. Occupy and set up booths before Friday June 14th 12:00am, we are allowing vendors to come on Thursday June 13th to set up booths there would not be an additional fee for this night.
2. If you decide to stay Sunday night An additional \$15 per person camping fee is required.

Break Down Options:

1. Vendors may begin to break down booths Sunday at 4:00pm .

Guidelines:

1. Vendors are not allowed to sell products that have not been written in the product application form.
 2. Please bring awareness in keeping the surrounding area around their booths clean and conduct business in a respectful manner.
 3. Vendor's Agree to be accountable for any damage to neighboring booths due to wind etc. canopies must be secured to the ground. Occasionally we get high winds so plan ahead or call us for ideas to secure booths.
 4. Vendors are responsible for the safety of their personal property damage, assuming full responsibility for any theft, damage, loss of products or personal injury, while on the Summer Lake Hot Springs property.
1. **Vendors will provide complete booth materials including:** shade and rain shelter, equipment, products and lighting.
 2. Signs must be of reasonable size and not infringing upon neighbors booth space.
